<ol style="list-style-type: none"> <li>1. All watercraft will be operated at "dead slow" speed with no wake or waves created by the watercraft.</li> <li>2. Audio and sound systems shall be used at low volume only.</li> <li>3. Operating the watercraft under the influence of alcohol will be reported to police and coastguard.</li> <li>4. Only the licensed operator of the watercraft is permitted to operate the watercraft.</li> </ol> <p>Failure to obey any of the Canal Rules will result in cancellation of the permission to use the canal and lock gates.</p>
